



BAC RESOLUTION NO. ISB-BFP 01-2025
A RESOLUTION DECLARING A FAILURE OF BIDDING FOR THE PROJECT
Waterproofing of the Philippine Embassy Complex

WHEREAS, the Philippine Embassy in Islamabad, through its Bids and Awards Committee (BAC) and Technical Working Group (TWG), conducted the procurement of services for the **“Waterproofing Project of the Philippine Embassy Complex”** pursuant to Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR);

WHEREAS, the procurement was undertaken through Public Bidding, with a total of ten (10) bidders submitting their bid documents within the prescribed period;

WHEREAS, the Opening of Bids was held at the Philippine Embassy on 15 October 2025 which commenced at 1004H, during which the first (technical) envelopes of the bidders were opened and examined using the non-discretionary pass/fail criterion under Section 30.1 of the IRR;

WHEREAS, upon evaluation, it was determined that all bidders failed to comply with one or more requirements prescribed in the Technical Proposal, and that one (1) bidder was additionally found non-compliant under the Financial Proposal;

WHEREAS, pursuant to Section 35.1(a) of the 2016 Revised IRR of R.A. 9184, a Failure of Bidding shall be declared when all bids fail to comply with the requirements or fail post-qualification;

WHEREAS, Section 35.2 of the same IRR further provides that in the event of a Failure of Bidding, the BAC shall conduct a re-bidding with re-advertisement or posting within seven (7) calendar days from the date of declaration, and that the procedures for re-bidding shall be the same as those of the original bidding;

NOW, THEREFORE, for and in consideration of the foregoing premises, the Bids and Awards Committee of the Philippine Embassy in Islamabad hereby **RESOLVES**, as it is hereby **RESOLVED**, to **DECLARE a FAILURE OF BIDDING** for the project entitled “Waterproofing Project of the Philippine Embassy Complex,” in accordance with Section 35.1(a) of the 2016 Revised IRR of R.A. 9184.

RESOLVED FURTHER, that the BAC Secretariat or TWG be directed to prepare the necessary documentation and to initiate the conduct of a Re-Bidding, to be posted within seven (7) calendar days from the date of this Resolution, pursuant to Section 35.2 of the IRR and the DFA Procurement Manual for Foreign Service Posts (Volume II);

RESOLVED FINALLY, that this Resolution, together with the Abstract of Bids and Minutes of the Opening of Bids, be transmitted to the Head of Procuring Entity for noting and approval.
