I. Call to Order and Opening Formalities

The Opening of Bids for the Waterproofing Services for the Philippine Embassy Building Complex was called to order at 10:09 a.m. by Mr. Juan Paolo G. Alix, Chairperson of the Bids and Awards Committee (BAC). The Chairperson stated that the proceedings were conducted pursuant to Republic Act No. 9184 (Government Procurement Reform Act), its 2016 Revised Implementing Rules and Regulations (IRR), and GPPB Resolution No. 28-2017.

- Each bidder should have submitted two sealed envelopes: (1) Technical and (2) Financial.
- Only bidders that pass the Technical evaluation will have their Financial proposals opened.
- To ensure order and fairness, comments or interruptions during the opening/evaluation would not be entertained; clarifications may be submitted in writing to the BAC Secretariat after the proceedings.
- The Committee upholds transparency, integrity, and equal opportunity in the procurement process.

VI. OPENING AND EVALUATION OF FINANCIAL PROPOSALS

Only the financial envelopes of bidders that passed the technical evaluation were opened, namely: Roof Line Pvt. Ltd., Build Fast, and DevPro Contractors & Engineers.

VII. Summary and next steps

The BAC declared the following as eligible for post-qualification:

- 1. Roof Line Pvt. Ltd. —PKr. 10,926,130.00
- 2. Build Fast PKr. 10,981,637.67

The Committee resolved to proceed with the Detailed Evaluation and Post-Qualification of these two (2) bidders in accordance with RA 9184 and its IRR. Should the evaluation be inconclusive or insufficient, the BAC may recommend adoption of Alternative Modes of Procurement consistent with the law.

VIII. ADJOURNMENT

There being no other matters to discuss, the meeting was adjourned at 11:15 a.m. The BAC expressed appreciation to all participating bidders and observers for their cooperation.
