**INVITATION TO BID FOR THE PROCUREMENT OF ONE (1) BRAND NEW MOTOR
VEHICLE**

The Embassy of the Philippines in Islamabad, Pakistan, through the General Appropriations Act of FY2021, intends to apply the sum of **Sixty-Two Thousand United States Dollars (USD 62,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of one (1) brand new motor vehicle as an official service vehicle. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Make/ Body Type:	Passenger Van
Engine and Fuel	Up to 2500cc Gasoline Fed or
Displacement:	Up to 3000cc Diesel Fed
Transmission:	Automatic
Exterior Color:	White/ Black/ Gray/ Silver
Warranty:	Maximum of 3 years' warranty, with additional 2 years (within the budget)
Height:	Not exceeding to 2.37 meters

Delivery of said vehicle is required within six (6) months from the date of signing of the contract.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion pursuant to the guidelines of the Philippine Government Procurement Reform Law (R.A. No. 9184) and Annex "A" of the Philippine Government Policy Board (GPPB) Resolution No. 28-2017.

Bidding is open to all interested bidders, whether local and foreign.
