# REQUIREMENTS

## NBI CLEARANCE GUIDELINES

### NBI CLEARANCE GUIDELINES

- The Embassy does not process NBI Clearance applications. Instead, it provides the NBI Fingerprint Card (Form No. 5) and guidance on how to get said clearance abroad.
- Note: The previously issued Form No. 5 (NBI Fingerprint Card) remains valid for use, notwithstanding the release of a newer version.

#### **For Filipino Nationals:**

Duly accomplished NBI Form No. 5 and assisted by the Consular assistant/Police Attaché for fingerprinting

**For Foreign Nationals:** Duly accomplished NBI Form No. 5, and assisted by the nearest Police Station of residency for the fingerprinting





# **REQUIREMENTS**

## **OVERSEAS ABSENTEE VOTING REGISTRATION**

### **OVERSEAS ABSENTEE VOTING**

For Filipino Citizens (Philippines Overseas Absentee Voting)

- Overseas Voter Registration Form (OVF1) – one printed copy, duly accomplished.
- Valid Philippine Passport – original and one photocopy.
- Proof of Current Filipino Citizenship – e.g., dual citizenship certificate if applicable.
- Other Identification – if a passport is unavailable, alternative government-issued IDs may be accepted





# REQUIREMENTS NEW APPLICANTS

## NEW PASSPORT APPLICANTS

### Adult:

- PSA birth certificate
- Marriage certificate if married woman using spouse's last name (PSA-issued)
- Valid government-issued ID
- No marriage certificate needed if married woman retains maiden name

### Minor:

- PSA birth certificate
- Parents' PSA marriage certificate
- Parents' original passports
- School ID or supporting documents
- Bring both original and photocopy of required documents







# REQUIREMENTS RENEWAL APPLICANTS

## RENEWAL PASSPORT APPLICANTS

### Adult Renewal:

- Photocopy of passport data page
- Accomplished application form

### Minor Renewal:

- Passport data page
  - Birth certificate (preferably PSA-issued)
  - Parents' marriage certificate (PSA)
  - Parents' passport data pages
  - School ID or valid ID (e.g., POC)
- 
- Bring both original and photocopy of required documents





# **REQUIREMENTS** **REPORT OF** **MARRIAGE (ROM)**

## **REPORT OF MARRIAGE (ROM)**

- Foreign Marriage Certificate
- ROM Form (4 copies)
- 4 Copies of passport data page
- Certificate of Live Birth of Filipino (PSA-issued) and birth registration certificate of foreign spouse (MoFAattested)
- Certificate of No Marriage (CENOMAR ) issued by PSA
- Special Case: applicant did not file ROM within 1 year from date of marriage—file an Affidavit of Delayed Registration of Marriage





# **REQUIREMENTS**

## **REPORT OF BIRTH (ROB)**

### **REPORT OF BIRTH (ROB)**

- Birth Registration Certificate (MoFA-attested)
- ROB Form (4 originals)
- Parents' Marriage Registration Certificate (MoFA-attested) or Marriage Certificate that is PSA-issued
- Parents' Passports
- Special Case: applicant did not file ROB within 1 year—file an Affidavit of Delayed Registration of Birth
- Special Case: Unmarried Parents—file an Affidavit of Acknowledgment of Paternity (AAP) and Affidavit of Consent to Use the Surname of the Father (AUSF)







# **REQUIREMENTS**

## **REPORT OF DEATH (ROD)**

### **REPORT OF DEATH (ROD)**

- Death Certificate issued by proper Pakistani authority
- ROD Form (4 originals)
- Passport of the deceased
- PSA Certificate of Live Birth of the deceased
- Supporting documents







# REQUIREMENTS

## NOTARIAL, JURATS

### NOTARIAL SERVICES

Passport copy of the applicant, and for Affidavit of Lost and Affidavit of Mutilation, additional requirements are any valid Philippine Government-issued IDs, Police Report, PSA Birth Certificate, and for married, PSA marriage certificate.

- For an Affidavit of Loss involving lost passports, a clearing period of fifteen (15) working days is required before a passport application can be accepted and processed.





## **REQUIREMENTS**

### **ACKNOWLEDGEMENT AND CERTIFICATION**

## **CONSULAR SERVICES**

Passport copy of the applicant, copy of visa or POC for SPA, need to submit a passport copy attorney-in-fact or any valid Philippine Government-issued ID.

- For the Employment Contract, both passport copies of the employer and employee.

**Note:**

No need for attestation from the Ministry of Foreign Affairs (MOFA).







## REQUIREMENTS AUTHENTICATION

### CONSULAR SERVICES

Passport copy of both parties and for Special Power of Attorney, General Power of Attorney, Deed of Sale, General Affidavit, Affidavit of Support & Consent, Affidavit of Support, Affidavit of Legal Capacity to Contract, or any valid Philippine Government-issued ID.

**Note:**

The document/s needs attestation from the Ministry of Foreign Affairs (MOFA).
