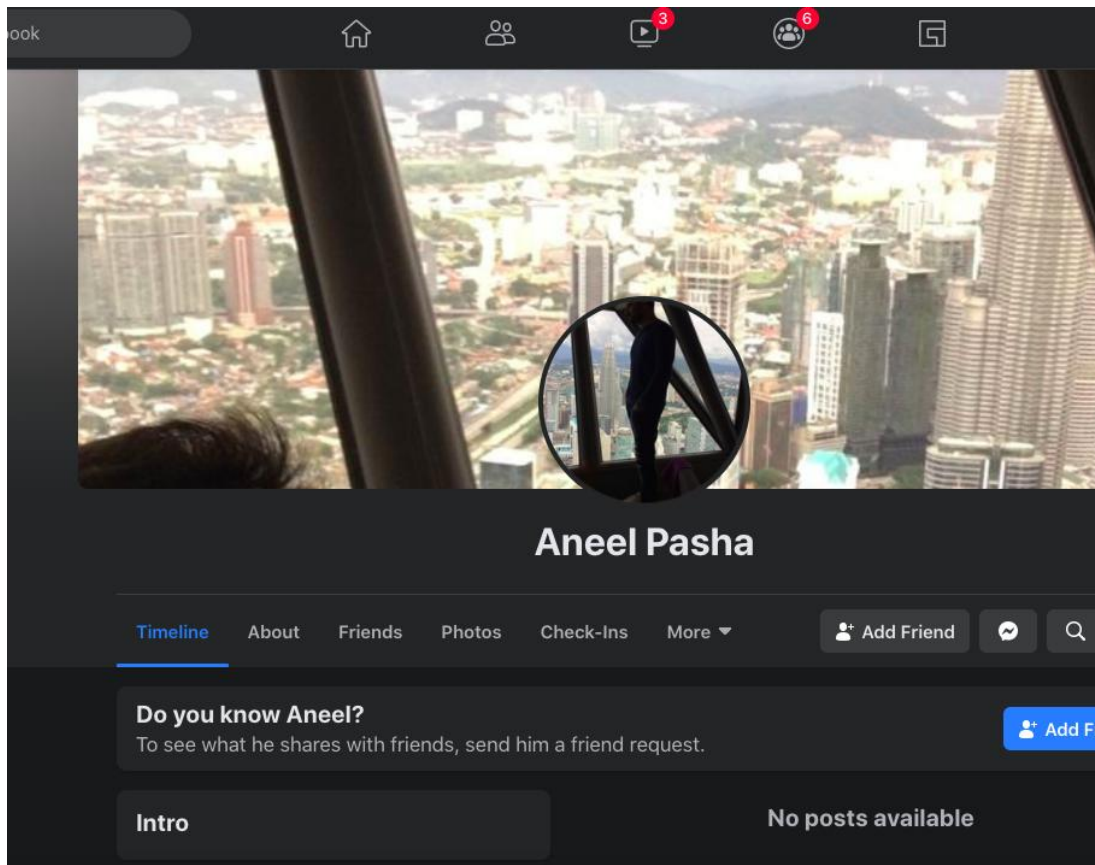
ADVISORY TO THE GENERAL PUBLIC AGAINST A FORGED LETTER FROM MR. ANEEL PASHA

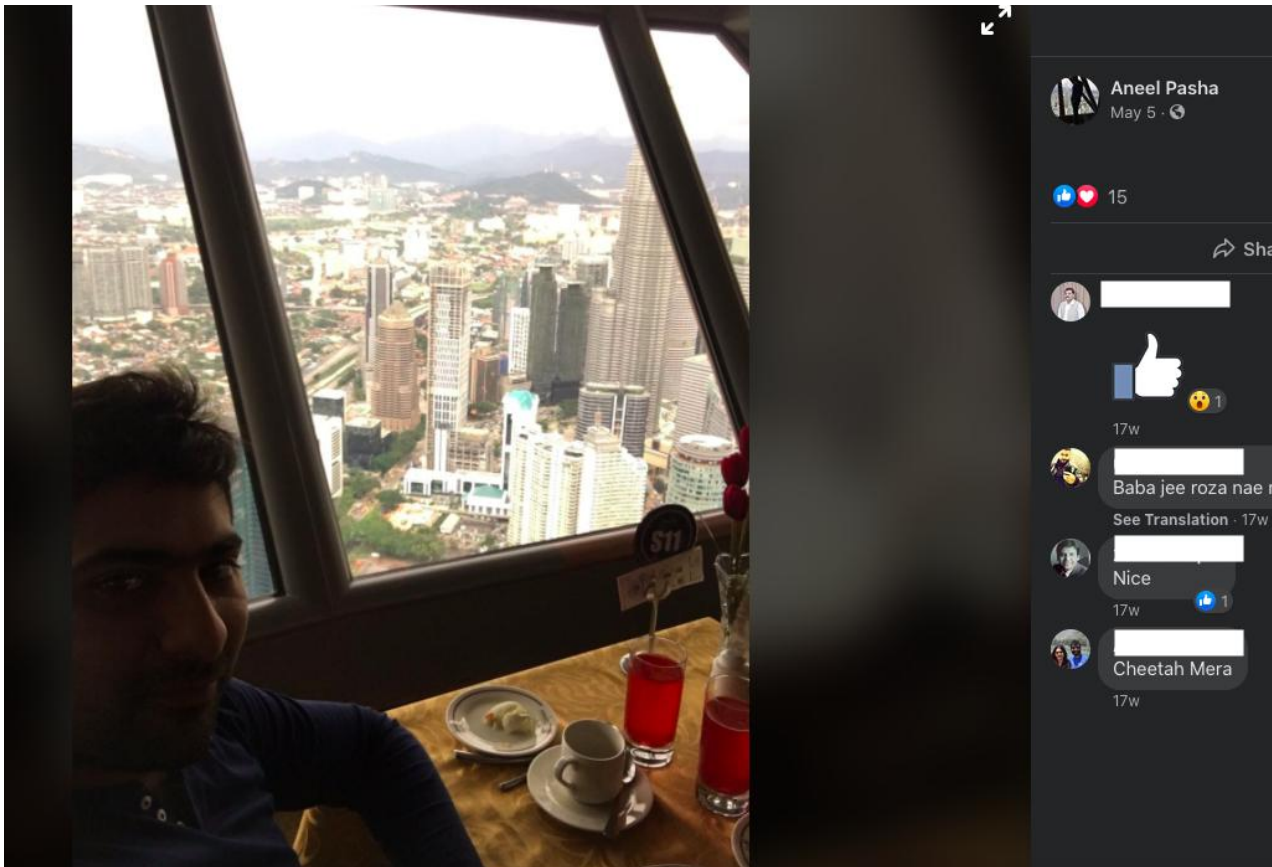

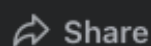
